- ii. Evidence of Company's Income Tax Clearance Certificate for the last three (3) years (2017, 2018 and 2019), valid till 31<sup>st</sup> December, 2020;
- iii. Evidence of current Pension Compliance Certificate valid till 31st December, 2020;
- iv. Evidence of Current Industrial Training Fund (ITF) Compliance Certificate valid till 31st December, 2020;
- v. Evidence of current Nigeria Social Insurance Trust Fund (NSITF) Compliance Certificate valid till 31<sup>st</sup> December, 2020;

vi. Evidence of registration on the National Database of Federal Contractors, Consultants and Service Providers by submission of Interim Registration Report (IRR) expiring on 31<sup>st</sup> December, 2020 or valid Certificate issued by BPP;

#### vii. A Sworn Affidavit:

- disclosing whether or not any officer of the relevant committees of the National Orthopaedic Hospital, Dala, Kano or the Bureau of Public Procurement is former or present Director, shareholder, or has pecuniary interest in the bidder and to confirm that all information presented in its bid are true and correct in all particulars;
- that none of the directors has been convicted in any country for any criminal offence including fraud or financial impropriety
- that the company is not in receivership, insolvency or bankruptcy
- viii. Evidence of Financial Capability by submission of reference letter from a reputable Commercial Bank in Nigeria, indicating willingness to provide credit facility for the execution of the project when needed;
- ix. Company's Audited Accounts for the last three (3) years, 2017, 2018 and 2019 duly stamped by a reputable audit firm;
- x. Comprehensive Company's profile showing organizational structure with Curriculum Vitae of relevant key staff to be deployed for the project, including copies of their Academic and Professional Qualifications;
- xi. Documentary evidence of at least three (3) similar jobs completed in the last five (5) years with Certificate of Completion or for 70% completion of on-going projects with Interim Performance Certificate including Letters of Awards and photographs of the projects
- xii. Letter of authorization from the original Equipment Manufacturers listed in the Approved Policy of Procurement of Health and Medical Equipment for Tertiary Hospitals in Nigeria, for bidders of Medical Equipment.
- xiii. For WORKS: List of Plants/Equipment with proof of Ownership/Lease
- xiv. For Joint Venture/Partnership, Memorandum of Understanding (MoU) should be provided (CAC, Tax Clearance Certificate, Pension Compliance Certificate, ITF Compliance Certificate, NSITF Compliance Certificate, IRR and Sworn Affidavit are compulsory for each JV partner)
- xv. All documents for submission must be transmitted with a covering/forwarding letter under the company/firm letter headed paper bearing amongst others the Registration Number (RC) as issued by the Corporate Affairs Commission (CAC), contact address, telephone number (GSM) and email address. The letter headed paper must bear the names and nationalities of the Directors of the Company at the bottom of the page, duly signed by the authorized officer of the firm.

Prospective bidders shall submit completed Technical and Financial Bids in two (2) hard copies, one copy of technical and one copy of financial bid with soft copy financial bids in MS EXCEL format packaged separately in sealed envelopes and labelled "Technical Bid" and "Financial Bid" respectively with the company name and address indicated at the back of the envelope. The two envelopes should be enclosed in one big sealed envelope and marked (Technical and Financial), clearly stating the project name and LOT number at the top right hand corner of the envelope and address to:

- iii. All Bids submission must be in English Language
